

***An Act for the Union of Aquria and the Government Thereof***  
*(March 29, 2025)*

## ***Preamble***

*Whereas the regions of Aquria have expressed their desire to unite into one nation under the authority of the Aqurian Parliament, with a Constitution rooted in democratic principles:*

*And whereas such a Union would benefit the regions and advance their collective interests:*

*And whereas, upon the establishment of the Union by the authority of Parliament, it is necessary not only to provide for the legislative authority of the nation but also to define the nature of its executive government:*

*And whereas provisions should be made for the eventual inclusion of other regions:*

## ***I. Preliminary***

### ***Short Title***

- 1. This Act may be cited as the Constitution Act, 2025.*

## ***II. Union***

### ***Declaration of Union***

*3. The governing authority, with the advice of the elected representatives, may declare by Proclamation that, on a specified date not exceeding six months from the passing of this Act, the regions of Aquria shall form a single nation under the name "Aquria." From that date, these regions shall constitute one unified democracy accordingly.*  
*Interpretation of "Aquria"*

*4. Unless otherwise stated, "Aquria" shall refer to the nation as established under this Act.*  
*Formation of Sixteen Districts*

- 5. Aquria shall be divided into sixteen districts:*
  - 1. Til*
  - 2. Erylia*
  - 3. South OGREBAN*
  - 4. Rienreich*
  - 5. Isle of Quartz*
  - 6. Rockstead*
  - 7. Vklia*

8. *North Ogreban*
9. *South Lavinia*
10. *Froendre*
11. *Deutesrampem*
12. *Cuttle*
13. *Mjth*
14. *North Lavinia*
15. *Alamunia*
16. *East Lavinia*

### ***Boundaries of Districts***

6. *The districts of Aquria shall maintain their existing boundaries at the time of this Act.*

### ***Decennial Census***

7. *A national census shall be conducted every two years, distinguishing the population of each district.*

## ***III. Executive Power***

### ***Executive Authority Vested in the Elected Government***

8. *The executive authority of Aquria shall be vested in an elected government, accountable to the people through democratic institutions.*

### ***Head of Government's Role***

9. *The Head of Government shall be elected by the Aqurian Parliament and shall oversee the administration of the nation in accordance with the Constitution.*

### ***Council of Ministers***

10. *A council, called the Council of Ministers, shall be appointed by the elected Head of Government and shall be responsible for advising on national governance.*

### ***Executive Authority***

11. *The powers of the executive branch shall be limited by law and subject to oversight by the elected Aqurian Parliament.*

### ***Appointment of Deputies***

12. *The Head of Government may appoint deputies to assist in the execution of national policies.*

## ***Command of Armed Forces***

*13. The command-in-chief of Aquria's military forces shall be vested in the elected government, with oversight by the Aqurian Parliament.*

## ***Seat of Government***

*14. Until otherwise directed, the seat of government shall be in a designated capital city.*

# ***IV. Legislative Power***

## ***Aqurian Parliament***

*15. Aquria shall have a Parliament, consisting of an autonomous Senate and the elected Aqurian Parliament, which shall function as the primary legislative and governing body.*

## ***Parliamentary Privileges***

*16. The privileges and powers of both the Senate and the Aqurian Parliament shall be as determined by Parliament, ensuring accountability and transparency.*

## ***First Parliament Session***

*17. The first Parliament of Aquria shall convene within six months of the Union.*

# ***The Senate***

## ***Composition***

*18. The Senate shall consist of elected representatives, with membership reflecting regional populations.*

## ***Autonomy of the Senate***

*19. The Senate shall be part of the Aqurian Parliament but shall operate autonomously in the exercise of its legislative powers. While it is part of the Parliament, its functions and decisions will remain independent of the Aqurian Parliament.*

## ***District Representation***

*20. Aquria shall be divided into sixteen districts, each with equal representation in the Senate.*

## ***Senatorial Qualifications***

21. *A Senator must:*

- *Be at least 13 years old.*
- *Be a citizen of Aquria by birth or naturalization.*
- *Be elected by the people of their district.*

## ***Senate Quorum***

22. *A majority of Senators must be present for the Senate to conduct business.*

## ***Voting in the Senate***

23. *Decisions in the Senate shall be made by majority vote.*

# ***V. General Provisions***

## ***Interpretation***

24. *In the event of a conflict between this Act and any other laws or policies, the provisions of this Act shall prevail.*
